Alexander Villalobos Background Investigation

Chief Medrano,

Based on my training and experience over the years of being involved with one of the best professions known to mankind, I believe it is common practice in the Law Enforcement Community that every Law Enforcement Agency establishes disqualifiers for any applicant. This information would include the agency application and the personal history statement such as:

Making false statements in any material fact; withheld information practiced or attempting to practice any deception or fraud in the application, examination, or appointment, depending on the variables involved, disqualification may be either permanent or temporary. This would include dishonorable discharge as a peace officer, where retired or resigned in lieu of termination for a criminal offense or terminated for a criminal offense with or without charges filed; retired or resigned in lieu of termination for administrative violations of truthfulness or insubordination, or terminated for administrative violations of truthfulness or insubordination.

I have been able to detect discrepancies within the Travis County Constable Pct. 3 (TCCO3)

Pre-Employment Questionnaire and Texas Commission On Law Enforcement (TCOLE)

Personal History Statement paperwork:

December 01, 2022

1) Have you ever applied to any other Law Enforcement agency? Explain the outcome.

Westlake PD – Applicant stated on the TCCO3 that he submitted the application, "nothing further." However, I spoke with a contact by phone that works at the Westlake PD in an unofficial capacity (off the record) regarding Alexander. I was told that Alexander is permanently disqualified from that agency due to the discrepancies found in Alexander's application. Also, Alexander listed Westlake PD on the personal history statement without providing the status (the outcome) of the application from Westlake PD.

B. <u>Austin PD (APD)</u> – Applicant stated on the TCCO3 that he applied and received a letter of hire, but due to the City of Austin reductions and delayed start of the academy, he accepted a

position with Texas State University PD. However, Alexander failed to provide that information in the personal history statement.

C. <u>Hays County Precinct 2</u> - I was able to ascertain information that Alexander applied for a Reserve Deputy position with Hays County Precinct 2. I spoke with the Constable and Chief Deputy in person in an unofficial capacity (off the record) regarding Alexander. I was told that Alexander is permanently disqualified from that agency due to the discrepancies found in Alexander's background.

December 08, 2022

On December 08, 2022, at approximately 0945, I met with Alexander Villalobos at 8656 Hwy 71, West Bldg. B, Austin, TX 78735 for the final review and changes to his Travis County Constable Pct. 3 (TCCO3) Pre-Employment Questionnaire and Texas Commission On Law Enforcement (TCOLE) Personal History Statement paperwork.

Alexander made changes:

1) Wrote a statement regarding being disqualified by Austin PD (APD). In Alexander's statement by his omission, he was disqualified for not reporting that he was under an IA investigation at Texas State University PD.

I asked Alexander a follow-up question regarding what he stated on the TCCO3 Pre-Employment about receiving a letter of hire with APD and the reason for leaving. He stated due to reductions and delayed academy that he accepted a position with Texas State University PD.

I asked Alexander based on what he stated it would indicate he was not working at Texas State University at the time he applied and received a letter of hire with APD. Alexander attempted to clear up my understanding by saying, "he meant a new position (Sgt.)."

- 2) Alexander updated that he is no longer employed at AnyPlace MD as of 11/26/2022.
- 3) Alexander updated that he applied with Austin Community College for a Sgt. position with no status. Stated he just turned in the application.

Additional Follow-up Questions and Answers:

- 1) I asked Alexander why he was disqualified from DPS after receiving a conditional letter of hire. Alexander stated that he was told that he was being deceptive, and he failed the polygraph exam multiple times.
- 2) By Alexander's own omission he has failed other polygraph exams multiple times.
- 3) I asked Alexander if he has applied with any other agency. Alexander stated he was a Reserve Deputy with Hays County Constable Precinct 3. Alexander said that the agency did away with the Reserve Deputies Unit and later re-established the Unit again after he left.

- 4) I asked Alexander if there was any other agency that he applied with full-time or reserve. Alexander stated "no." With Alexander replying "no," it continues to show that Alexander is being deceptive being that I unofficially viewed his file from Hays County Precinct 2.
- 5) Alexander said that he has been under investigation by the Hays County, County Court of Law for misuse of a county computer for personal use.
- 6) Alexander stated that there is a rumor of a list of officers in Hays County that he is on showing that he is not eligible to be hired in Hays County in law enforcement (similar to the Brady List of Officers in Travis County).

I asked Alexander if he ever seen the list. He replied no.

- 7) How many times have you been asked to resign from a job? Alexander answered "No, although my position as Chief of Staff of Hays County was defunded."
- 8) Alexander said he has been in a civil lawsuit in Travis County Justice of the Peace 3 over the sale of a home. Alexander said after the judgement was rendered, he satisfied the judgement.
- 9) I observed that on question 11 in the PHS packet under motor vehicle accident that requests details if you check yes. Alexander failed to provide any details in the space given on (p.32) in

Conclusion

I was able to locate many questionable articles regarding Alexander just by name search in google that are not becoming of a Deputy (character flaws), along with all the discrepancies that I have been able to detect in the application.

From my experience, character flaws and discrepancies of this magnitude could create a problem when filing cases or writing citations if an open records request was ever made.

Due to the Standard Practices in Law Enforcement Background Investigations and identifying the discrepancies listed, I am recommending that we do not move forward with this applicant.

I am closing out the Background Investigation on Alexander Villalobos.
